Public Comment:

John DeBartola stated his objections to the County providing \$100,000.00 to Vision 2025.

Edward Cernic, Jr., outlined capital projects that were previously completed by the County. He stated that he hopes that the Commissioners' Office will work together with the Controllers' Office in the future.

Motion was made by Commissioner Rager to waive the reading of the Minutes of October 24, 2024, but to approve them and place them on file.

Grants:

Motion was made by Commissioner Rager to approve submitting grant applications to the following entities for the stated projects and amounts:

- 1. Pennsylvania Emergency Management Agency Cybersecurity Grant, in conjunction with the Prothonotary's Office and the Sheriff's Office, for a backup server, in the amount of \$55,000.00.
- 2. National Historical Publications & Records Commission, for the Recorder of Deeds Office to update online storage for early County records and documents, in the amount of \$128,002.00.
- 3. Pennsylvania Department of Community and Economic Development Local Share Account, for roof repairs at the Central Park Complex, in the amount of \$150,000.00.
