

INSTRUCTIONS TO VOTER

- 2. To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval () to the left of the line provided, and write the name in the blank space provided for that purpose.
- 3. Mark ballot only in black or blue ink. Use the same pen for all markings you place on the ballot.
- 4. If you make a mistake DO NOT ERASE OR CROSS OUT. Ask for a new ballot.

WARNING

If you receive an absentee or mail-in ballot and return your voted ballot by the deadline, you may not vote at your polling place on election day. If you are unable to return your voted absentee or mail-in ballot by the deadline, you may only vote a provisional ballot at your polling place on election day, unless you surrender your absentee or mail-in ballot and envelope to the judge of elections to be voided to vote by regular ballot.
