Tax and Revenue Anticipation Note Revision:

Motion was made by Commissioner Rager to approve the revised proposal of First National Bank for a Tax and Revenue Anticipation Note, Series 2025, in the amount of \$10,000,000.00, at a fixed interest rate of 5.06%, as well as the corresponding Note Resolution.
